Account No:-5535019001279 ISFC Code:-PUNBORRBBGB MICR Code:-733830604 by NEFT / RTGS, Scanned Copy of the deposit sleep / Online payment received copy of the same should be uploaded as Statutory Document / Technical file ,failing which the application will be rejected.
- 2.Bidders must up-loaded the clear scan copy of PAN Card, Valid 15 digit GST Identification Number, last three years Income Tax Return,Profession Tax Registration Certificate with current challan and Trade Registration Certificate/License from local bodies as the case may be.
- 3.Bidders must up-load Credential is similar nature of work during last three years.
4. In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- 5.Bidders must quote rates in percentage (less/Above) basis against the estimated cost and must fill Bidders name in BOQ.
- 6.Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shallnot be allowed.
- 7.The prospective bidders shall have their full time engagement experienced technical personnel, with the sufficient knowledge ofPERT/CPM, the minimum being one Civill Engineer of Diploma holder (Authenticate documents in respect of qualification and engagementshall be furnished for Technical Evaluation). (It is applicable for the tender/Work value above 8 lakh).
8. No special preferences in respect of Earnest money, Security Deposit etc. will be given to any Co-operative Society/Government owned Company/Government Undertaking/Corporation/Engineering Co-operative etc. in other word, all participating Bidders will be treated on equalbasis only and no favourable/special considerations will be accorded to any bidders.



9. The original Demand Draft /DCR against Earnest money Deposit(EMD) should be submitted only 1st Lowest Bidder physically.
10. Successful Bidder(s) Will be required to lodge security deposit (10% of the total value of the work as quoted by him) as performance security in the form of Cheque/Bank Draft/Securities duly pledged in favour of the Pradhan, Surjapur-I Gram Panchayat or the amount may be deducted from every running payment (not exceeding three including the final bill) made and will be released 6 months in case of Building, Culvert and Concrete Roads and 3 months in all other case.
11. IT,SGST,CGST" and labour Cess will be deducted as per existing rates fixed by the respective department of the government.
12. Site visit may be done by the bidders at their own cost.
13. The Pradhan Surjapur-I Gram Panchayat reserves the right to reject or cancel any or all prequalification documents and tender documents without assigning any reason whatsoever.
14. Bidder(s) may be asked to submit rate analysis for items where the quoted rates are either below or above 5% than the estimated cost. Such bids may also be considered as null and void if there is a reason to believe that the Bidder have formed a cartel and rates have been Manipulated, unbalanced or unreasonable.
15. Successful bidder will have to execute a formal contract on a Non-Judicial Stamp paper within seven days from the receipt of "Letter of Acceptance with the Gram Panchayat wherein the description, specification, quantity, date of completion of work, other mandatory conditions and ESMF (Environmental and Social Management Framework) issues shall be detailed. Failure to execute the contract will lead to automatic cancellation of the bid.
16. The undersigned is not bound to accept the lowest tender and reserves the right to accept or reject any or all tenders as the case may be without assigning any reason whatsoever.
17. Quoted rate shall be inclusive of all charges including royalty, loading un-loading tools charges transportation etc. but excluding GST & labour cess.
18. The successful tenderer will have to procure Non-Judicial Stamp paper in his/her own cost.
19. The bidders should have to submit authentic E-mail address of Farm/Proprietor for future communications.
20. The successful tenderer will have to procure material testing report and water testing report before paying his work bill.
21. The Job Card holders shall be mandatorily be engaged by the contractor / agency where rural unskilled workers can be engaged.
