The list of Qualified Bidders will be displayed in the website on the scheduled date and time.
2. Running / final payment for work may be made to the executing agency as per availability of fund.
3. **Bids shall remain valid** for a period not less than 120 (One hundred twenty) days after the dead line date for Financial Bid submission.

- The Bidder, at his own responsibility and risk is encouraged to visit and examine the site of works and its Surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Tender, before submitting offer with full satisfaction. The cost of visiting the site shall be at his own expense.
- The intending Bidders should clearly understand that whatever may be the outcome of the Present invitation of Bids, no cost of Bidding shall be reimbursable by the Department. The Tender Inviting authority reserves the right to reject any or all the application(s) for purchasing Bid Documents and/or to accept or reject any or all the offer(s) without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Tenderer at the stage of Bidding.
- The intending tenderers are required to quote the rate **online only**, no offline tender will be entertained.
- The tender inviting authority reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
- In case of any objection regarding disqualification of any Agency that should be lodged to the tender inviting authority within **1 day** from the date of publication of the list of qualified agencies and beyond that time schedule no objection will be entertained.

- Work order will issued as per availability of fund.** Before issuance of the **WORK ORDER**, the tender inviting authority may verify the credential(s) and/or other document(s) of the lowest tenderer. After verification, if it is found that the document(s) submitted by the lowest tenderer is/are either manufactured or false, the work order will not be issued in favour of the said Tenderer.

- Intending tenderers are required to submit online self-attested photocopies of all valid company details, valid partnership deed (in case of partnership firm), current Professional Tax Deposit Challan / Professional Tax Clearance Certificate, PAN Card, GST registration No/ Certificate, Trade License from the respective Municipality, Panchayet etc. Upto date audit report and proper credential of similar nature of work as per G.O. 04- A/PW/O/10C-02/14 dt. - 18/03/2015 should be submitted. Payment Certificates in lieu of credentials will not be accepted. [Non statutory documents].
- All tenderers are requested to be present online during opening of tenders positively. If considered necessary, instant online bid may be conducted immediately after opening of tenders to lower down rates and in no case his/their absence will stand against holding the same.

13. The intending tenderer is required to quote the rate in figures as well as in words as percentage above / below than or at par with the relevant price schedule of rates. Conditional / Incomplete tender will not be entertained.
14. The accepting authority reserves the right to reject any or all the tenders without assigning any reason whatsoever and he will not be bound to accept either the lowest tender or any of the tenders.
15. Issuance of Work Order as well as payment will depend on availability of fund and no claim whatsoever will be entertained for delay of Issuance of work order as well as payment, if any. Intending tenderers may consider these criteria quoting their rates.
16. If any tenderer withdraws his offer before acceptance or refuse within a reasonable time without giving any satisfactory explanation for such withdrawals, he shall be disqualified for submitting tender to this office for minimum period of 1(one) year.
17. Professional Tax (PT) deposit receipt challan for the current financial year, PAN Card, last 3 years IT return, 15- digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act 2017 (Amendment of Rule 47(9)(b) of WBFR, Vol-I vide memo no 4374-F(Y) dated 13.07.2017 of Finance Department (Audit Branch), Govt of West Bengal) and latest challan.
18. Cess @ 1% (One Percent) of the cost of construction works will be deducted from the bills of the contractors on all contracts awarded on or after 01.11.2006 in persuasion with G.O. No. 599A/4M-28/06 dated 27.09.2006. Deduction of I. Tax should be made as per rule in vogue.
19. Release of Security Deposit will be made as per G.O.
20. All risks or damage to physical property and of personal injury and death which may arise during and in consequence of the performance of the contract will be borne by the contractor.
21. The contractor shall be responsible for the safety of all activities on the site.
22. The Job card holder should mandatorily be engaged by the contractor / agency where rural unskilled workers can be engaged. The contractor / agency executing the work shall also furnish a certificate after completion of work that only Job card holders were engaged for unskilled works during execution. The guideline of "Karmashree" scheme issued by the special secretary, P & RD, Govt. of W.B. vide G.O. No. 1138(Sec-PRD-33011/1/2024-MGNREGA SEC dated 07.03.2024 must be followed by the implementing agency during engagement of unskilled workers for the said job.

- ii. Tender form No. 2911(ii) & NIT (Properly uploaded and digitally signed). The rate will be quoted in the BOQ. Quoted rate will be encrypted in the B.O.Q. under Financial Bid. In case quoting any rate in 2911(ii) the tender is liable to be summarily rejected.

#### A-2. Non statutory / Technical Documents

- i. Current Professional Tax (PT) deposit receipt challan, IT return, PAN Card
- ii. Registered Deed of partnership Firm and Power of Attorney.
- iii. Valid Trade License from the respective Municipality/Panchayat etc.
- iv. Requisite Credential Certificate of similar nature of work
