The intending tenderer shall have to submit valid PAN issued by the IT Deptt., Govt. of India, I/Tax(current), Professional Tax(current), valid 15-digit Goods and Services Taxpayer Identification Number (GSTIN) under GST Act,2017 along with satisfactory completed as a prime agency during the last 5 (five) years prior to the date of issue of this Notice at least one similar type of work under authority of State / Central Govt., State / Central Government undertaking / Statutory Bodies and reputed any other concern

Rate should be quoted in % (Percentage) in respect of project cost. The rate will include all taxes etc.

The tender documents will be opened on 01-Nov-21 at 4.00 P.M in presence of tenderers in the Tender Section of Uttar Dinajpur Zilla Parishad.
