6. Last Date/Time of receipt of bids through e-tendering: 23-06-2023 (dd/mm/yy) upto 16.00 P.M

7.Only online submission of bids is permitted, therefore; bids must be submitted online on website www.wbtenders.gov.in. The technical qualification part of the bids will be opened online at 16.00 P.M (time) on 26-06-2023 by the authorized officers. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened online on the next working day at the same time.

8.The bids for the work shall remain valid for acceptance for a period not less than 180 (One eighty) Days after the Opening of Financial Bid. The bidders shall have to furnish a declaration executed through prescribed affidavit in non-judicial stamp paper of appropriate value duly notarized.

9.Bidders may bid for any one or more of the works mentioned in the Table above. To qualify for a package of contracts made up of this and other contracts for which bids are invited in the same NIT, the bidder must demonstrate having experience and resources sufficient to meet the aggregate of the qualifying criteria for the individual contracts.

Central/State Government undertaking/Statutory Bodies and having 60 (sixty) percent of the estimated amount put to tender. Estimated amount, Tendered Amount, Actual date of completion of the project and detail address for communication must be indicated in the Credential Certificate.

Credential: Scanned copy of work credential issued in favour of the contractor/bidder as detailed below:

In case of execution of supplementary/substitute supplementary items having values more than 30% of BOQ, final gross value of bill (without contractual rates) including such supplementary/ substitute supplementary items may be considered to ascertain similarity in nature of work and authenticated copy of such bills may be uploaded, if made available and desired by the bidder.

ii)The prospective bidders shall have in their full time engagement experienced technical personnel, with the sufficient knowledge of PERT/CPM, the minimum being valid Electrical License, one Electrical Engineering Degree holder and one Electrical Engineering Diploma holder with supervisor (Authenticated documents in respect of qualification and engagement shall be furnished for Technical Evolution).
