The cost of visiting the site shall be at his own expense.
- Register Partnership Deed in case of partnership firm has to be submitted. The company shall furnish the Article of Association ans Memorandum. Where an individual persion holds a digital certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner, such individual persion shall where uploading any tender for on behalf of the company or firm invariablely upload a copy of register power of attorneyshowing clear authorisation in his favour, by the rest of the director of such com[pany or the partner of such firm to upload such tender. Contructors are During security if it comes to notice of the tender inviting authority that the credential or any other paper found incorrect/manufacture/fabricated, that bidder would not be allowed 13 to participate in the tender and the application will be rejec without any prejudice.

The contructor's responsibility to keep the road open to all kind of traffic duribng the execution of work. No claim whats so ever will be entertain for idle labour, establishment cost of hire and labor charges of tools and plants and any unwanted incidance etc. at any circumstances.

Bidder(s) may be asked to submit rate analysis for items where the quated rate are either below or above 5% than the estimated cost. Such bids may also be considered as null and void if there is a reason to belive that the bidder have formed a cartel and rates have been manupulated, unbalanced or unreasonable.

Contructor should maintan Covid-19 precotion (Social distance mask sanitizer etc.) at work place as per govt norms and no claim will be entertained for such type of expenditure 16 incurred by the contructor.

In case of any objection regarding disqualification of any Agency that should be lodged to the tender inviting authority within 1 day from the date of publication of the list of qualified

agencies and beyond that time schedule no objection will be entertained. Before issuance of the WORK ORDER, the tender inviting authority may verify the credential(s) and/or other document(s) of the lowest tenderer. After verification, if it is found that 18

the document(s) submitted by the lowest tenderer is/are either manufactured or false, the work order will not be issued in favour of the said Tenderer. 19

All tenderers are requested to be present online during opening of tenders positively. If considered necessary, instant online bid may be conducted immediately after opening of tenders to lower down rates and in no case his/ their absence will stand against holding the same. 20

The intending tenderer is required to quote the rate in figures as well as in words as percentage above/ below than or at par with the relevant price schedule of rates. Conditional/ Issuance of Work Order as well as payment will depend on availability of fund and no claim whatsoever will be entertained for delay of Issuance of work order as well as 21

payment, if any. Intending tenderers may consider these criteria quoting their rates. If any tenderer withdraws his offer before acceptance or refuse within a reasonable time without giving any satisfactory explanation for such withdrawals, he shall be disqualified for 22

submitting tender to this office for minimum period of 1(one) year. Successful Bidder (s) will be required to lodge security deposit (10% of the total value of the work as quoted by him) deducted from every running payment (not exceeding three

including the Final bill) made and will be released as per G.O. 24

All risks or damage to physical property and of personal injury and death which may arise during and in consequence of the performance of the contract will born by the contractor. Time is the essence of contruct. The successfully contructor must start the work within seven days from the date of signing of agreement/contruct failing which the undersigned may

cancelled the work order and contruct and forfit the earnest money. The work should be completed within the prescribed time. No extention of time will be allowed accepted in special cases if it is found that the delay caused due to such reason which is beyond the controll of the contructur and on the issue wheather any reason is beyond the control of the contructor, the decision of the undersigned shall be final.

25 A. A penulty @ of 0.1% (Zero point one percent) of the value of the work may be imposed on per day of delay.

If during execution of work it is found that the progress of work is very slow and the contructor failed to speed up the work even after repeated reminders and the work is going to be delaid unnecessarily due to fault on the part of the contructor and/ or the quality of work is not as per the plan and estimate and the contructor does not make required rectification after being so instructed, the work order and contruct shall be cancelled, the earnest money shall be forfitted, the contructor may be black listed and claim of payment of work already executed before such termination, may not be considered or entertained.

In case of such mid-term termination of the work order and contruct at, the undersigned may also proceed to get the balance work completed by engaging other contructos's agencies 25 C. or departmentaly. The excess expenditure if any, due to such a step would be recoverable from the unpaid bills of the defaulting contructor, if claim of such bills has not been forfitted at the time of termination of work order and contruct as mentioned at point be above.

As per Order 4608-F(Y) Dated 18.07.2018 of Additional Cheif Secretary, WB Additional Performance security @ 10% of the tendered amount shall be obtained from the successful bidder if the accepted bid value is 80% or less of the Estimate put tender. Additional Performance security shall be submitted in in the form of Bank Guarantee from any 26 Scheduled Bank before issuance of the work. If the bidder fails to submit the Additional Performance Security within seven working days from the date of issuance of Letter of Acceptence, his Earnest mony will be forfeited and other necessary actions like Blacklisting of Contructor. The Guarantee Amount will be returned immediately on successfully completion of the contract. If the bidder fails to complete the work successfully, the Additional Performance security amont shall be forfeited any time.

- 27 Agency must submit relavent test reports of materials or works as per requirement.
- 28 The intending tenderers are required to quote the rate online only, no offline tender will be entertained.
- 29 The tender inviting authority reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
- 30 Schedule of Rates applicable for execution of the work(s) is current P.W.D. Schedule of Rates.
- 31 Departmental materials will not be issued. Materials will be purchased by the contractor.
- 32 In case of bid/tender emanating from cartelization of bidders, entire tender process will be cancelled.
- 33 Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.
- 34 GST, ITDS and Labour Cess will be deducted as per existing rates fixed by the respective department of the Government.
- 35 Water tsting rport must be submitted with permissible limit for potable water work with final bill submission.
- 36 Erroneous or incomplete e-Tender will be summarily rejected without assigning any reason whatsoever.
- 37 Quoted rate shall be inclusive of all charges including royalty, tools charges, transportation etc.
- 38 Joint venture will not be allowed.
- 39 The contractor shall be responsible for the safety of all activities on the site.
- 40 Job Card holders shall be mandatorily be engaged in the Departmental works where rural unskilled workers can be engaged.
- 41 The contractor/ agency executing the work shall also furnish a certificate after completion of work that only Job Card holders were engaged for unskilled works during execution.
